## TRANSFER GUIDANCE

### Guaranteed Admission Agreement

**By meeting the following criteria, you are guaranteed admission to Marymount University:**

- Virginia Community College (VCCS) students graduating from transfer-oriented degree programs with a cumulative GPA of 2.5 or higher on a four-point scale are guaranteed admission.
- This policy applies to undergraduate majors.
- Students must have upheld standards of student conduct. VCCS students who do not meet these terms may still apply and be considered for admission, although admissions are not guaranteed. Marymount University reserves the right to deny admission or enrollment to students who have been academically dismissed or suspended or to those convicted because of a felony.

Students with 2.2-2.5 GPAs are encouraged to apply. We always review individual cases.

### IS THIS DEGREE RIGHT FOR ME?

- **Get a head start on the rapidly changing world of business with a Bachelor's in Business Administration degree from Marymount University.** With a B.B.A. degree from Marymount, you'll acquire the knowledge and competencies of basic business, marketing, and accounting concepts. You'll learn to collaborate in a team environment and communicate business analytic terms effectively. You'll gain a global perspective on business and learn the right business technologies for processing market information and arriving at conclusions. And, you'll come to understand relevant ethical standards in contemporary business issues and practices.

### WHAT IS THE IMPACT ON MY DEGREE OF WORK I HAVE ALREADY COMPLETED?

- **Associate Transfer Degree Completion:** This degree fulfills all Marymount general education requirements except for Theological Inquiry (TRS 100), which can be taken in the first year.
- **Dual Enrollment:** Courses may count toward general education requirements. Completing an Associate Degree through dual enrollment does not automatically satisfy all general education requirements at Marymount; all dual enrollment courses will be considered on an individual basis.
- **Credit for Prior Learning:** Credit for prior learning, including CLEP examinations and AP and IB test scores, will be evaluated on a case-by-case basis for Marymount credit. Visit [www.transfervirginia.org](http://www.transfervirginia.org), "Check All My Credits," to see how your prior learning will earn credit at Marymount.
- **Catalog Year:** Transfer students follow the requirements in the catalog year that they first enter Marymount or the catalog year aligning with program enrollment in the VCCS (within 3 years.)
- **Total Credits:** Typical semester courses at Marymount carry 3 credits, 1 credit for lab courses

#### WHAT CAN I DO WITH THIS DEGREE?

With a Bachelor's in Business Administration degree from Marymount, you'll be prepared for entry-level positions throughout the multifaceted world of business — from small organizations and nonprofits, to large corporations and government agencies. Graduates may pursue careers as an Accountant, Budget analyst, Labor relations specialist, Market researcher, Purchasing manager, and more

Overall employment in business and financial occupations is projected to grow 7% from 2021 to 2031, about as fast as the average for all occupations, resulting in about 715,100 new jobs over the decade. According to the U.S. Bureau of Labor Statistics, the median pay for college graduates with business degrees in 2021 was \$76,570.

#### PROGRAM SUCCESSES & HIGHLIGHTS

- The Bachelor in Business Administration (B.B.A.) program is unique in that it offers a breadth of understanding of business as well the opportunity to explore more deeply (via minors) traditional areas of business (e.g., Marketing or Finance), or topics with a technology emphasis (e.g., Cybersecurity or Data Science).
- Internships integrate classroom learning with hands-on professional experience. Marymount B.B.A. students have worked as interns at Booz Allen Hamilton, Ernst & Young, Marriott, Morgan Stanley, National Geographic Society, National Technical Information Service, RedPeg Marketing, SAIC, the Smithsonian Institution, United Way, U.S. Congress, Volkswagen Group of America, and the Washington Commanders. Some B.B.A. students even intern overseas through Marymount Global.
- As part of the College of Business, Innovation, Leadership, and Technology (BILT), the B.B.A. offers a unique opportunity to explore and build connections between business and technology. You can combine state-of-the-art, foundational business courses with minors in Cybersecurity, Data Science, or other IT-focused programs, as well as Fashion Merchandising,

Design Studies, or Sports Management. Or, pair your B.B.A. with a traditional minor in Marketing or Finance. There are 20 minors for B.B.A. students to choose from, including a new minor in Entrepreneurship.

#### DO MORE WITH YOUR DEGREE!

- Students pursuing a BBA are encouraged to satisfy major requirements through a variety of interdisciplinary minors offered in the College. Students can also get a jump start on graduate coursework through our BBA to MBA pathway program, and accelerate their master's degree. Students may apply once they have at least 60 credits earned.

#### OTHER THAN CLASSES, ARE THERE OTHER PROGRAM REQUIREMENTS?

- There are three components to the BBA program. First, is a series of general education courses required of all students at Marymount University — “The Liberal Arts Core (LAC).” These non-business courses offer students the breadth of knowledge and skills needed to succeed in today's complex global, business environment.
- Second, is “The BBA Core” (see below). That is, all BBA students take courses in accounting, business law, economics, finance, international business, management, management science, and marketing. These courses create the foundation upon which students build their business expertise.
- Third, typically beginning in the junior year, students begin their “deep dive” into an area of specialization. We call these areas of specialization, “The Minor.” The Minor is a means of creating a highly customized program to meet students' interests and provide them with the credentials and skills that employers in the “What's Next Economy” expect. The SBT has minors in all the traditional areas of business (i.e., Economics, Finance, Entrepreneurship, Human Resource and Talent Management, International Business, Marketing, and Sport Management). And if you're interested in focusing more deeply in the field of Accounting, there is the B.S. in Accounting program. Additionally, as an alternative means of customizing their program, students may opt to pursue their BBA minor in an Information Technology related field.
