DO MORE WITH YOUR DEGREE!

 Accounting graduates are qualified to sit for the CPA Examination in Virginia (150 college credits are required to receive CPA licensure). This program leads to graduate programs including the MBA, the Master of Accounting, the MS in Accounting, and the MS in Taxation.

OTHER THAN CLASSES, ARE THERE OTHER PROGRAM REQUIREMENTS?

- All students must complete 120 total credit hours and all BBA/major requirements.
- Students must earn an overall and major GPA of 2.000. The major GPA is defined as all courses in the BBA core and all courses prescribed for the major.
