### Guaranteed Admission Agreement

By meeting the following criteria, students who complete the prescribed curriculum and meet the criteria below are guaranteed admission into Radford University and directly into the Davis College of Business.

- Earn a transfer associate degree based on the Business Admin Curriculum
- Earn a minimum of 2.8 GPA for the associate degree
- Good academic standing at current institution

### IS THIS DEGREE RIGHT FOR ME?

- The BBA with a major in Accounting prepares students for careers in public, industrial, service, governmental and non-profit or tax accounting.
- Through the Accelerated Master of Business Administration (MBA) program, high performing students may take 3-12 credit hours of graduate coursework that applies to both the BBA and the MBA.

- **Associate Transfer Degree Completion:** The completion of the transfer-oriented degree program will satisfy the REAL Curriculum (lower division/general education) requirements. Students will need to complete all other University, college, and departmental requirements in order to obtain the baccalaureate degree from RU.
- **Dual Enrollment – Completion of Associate Degree in HS:** Students completing the associate degree in high school should apply using the freshman application. If admitted, the student will receive the benefits associated with the transferable associate degree (as noted prior).
- **Credit for Prior Learning:** AP, IB, and CLEP are evaluated for credits (based on receipt

#### DO MORE WITH YOUR DEGREE!

- Accounting graduates are qualified to sit for the CPA Examination in Virginia (150 college credits are required to receive CPA licensure). This program leads to graduate programs including the MBA, the Master of Accounting, the MS in Accounting, and the MS in Taxation.

#### OTHER THAN CLASSES, ARE THERE OTHER PROGRAM REQUIREMENTS?

- All students must complete 120 total credit hours and all BBA/major requirements.
- Students must earn an overall and major GPA of 2.000. The major GPA is defined as all courses in the BBA core and all courses prescribed for the major.
