TRANSFER GUIDANCE

Guaranteed Admission to University of Mary Washington

By meeting the following criteria, you are eligible for admission to UMW:

- Earn a transfer associate degree.
- Earn a minimum GPA of 3.0 for your associate degree.
- Earn grades of "C" or higher in all community college courses to be eligible to transfer those credits.

Additional requirements to be eligible for immediate admission into the College of Business:

- Complete ACC 212 (equivalent to UMW's ACCT 102) with a C or better for admission to the College of Business. ACC 211, ECO 201, ECO 202, and MTH 155 (or MTH 245 or BUS 224) are highly recommended.
- Please create an account through the <u>www.TransferVirginia.org</u> portal to indicate your intent to use this guarantee for admission to UMW.

WHAT SHOULD I CONSIDER WHEN SELECTING COURSES?

- Create a schedule for all required courses, pay attention to prerequisites and when courses are
 offered, complete your first math and English courses in your first year. For help, see Transfer

- UMW requires proficiency in a second language as part of the general education requirements.
 This can be satisfied in a number of ways including completing four years of language in high school, transferring credits from a community college, or completing a sequence of language courses through the 201 level at UMW. IS THIS DEGREE RIGHT FOR ME?

- The UMW Business Administration degree program provides depth and breadth in all the core
 areas of business administration while providing students considerable flexibility in the courses
 they can choose.
- Majors are offered in Accounting, Business Administration, International Business, Management & Entrepreneurship, and Marketing.
- All students complete a common core of upper-level courses in Decision Sciences, Finance, Management, Marketing, and Business Communication.
- An additional 18 credits of restricted upper-level electives provide focus in the student's chosen major.
- UMW is accredited by AACSB (Association to Advance Collegiate Schools of Business)

WHAT IS THE IMPACT ON MY DEGREE OF WORK I HAVE ALREADY COMPLETED?

- Associate Transfer Degree Completion: Transfer students with a VCCS transferable associate
 degree have completed the UMW general education requirements except language
 competency, digital intensive, diverse and global perspectives, after Mary Washington, and
 beyond the classroom requirements. UMW allows students to satisfy these requirements
 through qualifying transfer coursework.
- Dual Enrollment Completion of Associate Degree in HS: Students participating in dual enrollment programs are considered as freshman applicants. Dual enrollment courses taken at the high school are treated identically with the same courses taken on a college campus; dual enrollment status does not affect the transferability of the course. Students completing a VCCS transferable associate degree in high school are eligible to be considered under the Guaranteed Admission Agreement.
- Credit for Prior Learning: UMW accepts credit for AP, IB, CLEP, Cambridge, and other qualifying previous coursework. Equivalencies are provided here:

- Catalog Year: Students must complete the general education requirements associated with the
 academic year they enroll at UMW. Students complete major requirements associated with the
 year they declare their major.

- Students must earn at least 30 credits at UMW as a degree seeking student (not including physical education credits).
- Students must earn a GPA of 2.0 or higher in both their major and overall coursework to complete their degree.
