Guaranteed Admission Agreement: VSU/VCCS GAA

By meeting the following criteria, you are Guaranteed Admission to Virginia State University

- Students must complete AA, or AS degree program
- Students must earn a "C" or higher in courses for transfer
- Students must earn a 2.0 GPA and higher
- The Pre-Business phase consists of 60 credit hours of coursework consisting primarily of the General Education curriculum.
